The Department of Education U.T of Lakshadweep invites online application for the following BE/ B.Tech courses reserved at cochin university of science and technology for students from Lakshadweep. **The last date for the submission of online application for BE/B.Tech is 28th September 2020** . The aspiring candidates, appeared in JEE 2020 and fulfill eligibility criteria are directed to apply online by accessing the site <https://ecounselling.utl.gov.in>. Candidates are requested to read the instructions carefully before filling the application to ensure their eligibility for different courses as per the rules laid down by the Lakshadweep Administration for the allotment of seat for higher studies.

The Engineering seats reserved by the Cochin University of Science & Technology (CUSAT) shall be allotted through online as per the merit order in JEE 2020-2021 and the guidelines of the University. **Candidates already submitted online application for Post SSLC/ Plus two courses also need to submit fresh online application for the above courses.** As in the case of previous year (2019-2020) allotment of seats will be made by counseling centers in the specified schools of islands

All the candidates should take the print copy of the online application and submit to the Registration officers (Principals of all Senior Secondary Schools under Department of Education) along with the following documents.

1. Schedule Tribe Certificate.
2. SSLC (10th Standard) and Plus Two Board Exam Passed Certificate
3. Copy of the mark list of the qualifying examination (Class X / XII)
4. Mark list of JEE 2020
5. Birth Certificate etc.

The Registration officer may consolidate the applications received by them and have to verify the applications online. No Officers other than the Principals / Head masters of Senior Secondary Schools are authorized to receive the filled in application.

While receiving the filled in application , the authorized officers may ensure that no applications other than that of son/daughter, legally adopted son or daughter of local inhabitant of Lakshadweep / employees of Lakshadweep Administration / employees of such organizations which are working under Lakshadweep Administration /employee of Central Government, Public sector undertaking etc, which are having registered offices in Lakshadweep and having their headquarter in the island and the ward has studied at least for one year in a School / College situated in Lakshadweep (The provisions of

Lakshadweep seat allotment rule shall be applicable). All employees other than the ethnic native of Lakshadweep should invariably attach a copy of services certificate of parent (Father or Mother) as well as detailed certificate about their ward's studies in the island Schools / Colleges in support of their claim for priority category, failing which their claim will not be considered.

Course availability / institution details are published in the website are prepared as per the data available with the Department and the candidates are directed to further verify the details of the course structure, eligibility criteria and nature of the course/College (Self finance, autonomous, University and related issues pertaining to the course/institution etc) directly with the concerned institution by themselves before selecting college and course as there will not be further chance for the candidate once she/he accepted the course.

The Department will not accept any kind of plain application for the online seat allotment and hence the candidates are directed to submit their applications through online mode only. No recommendation letter shall be issued to the students as per their request for any course.

The applicants are required to furnish unique mobile number against each application in a course level and the same will be verified by means of OTP at the time of registration. This would ensure that the information sent with respect to allotment 2020 is reaching on candidate mobiles. At the time of registration itself candidates can enter their marks and the Center they opted for counseling.

Rules framed by the Lakshadweep Administration for the purpose is applicable for the allotment of higher study seats.

While filing the application form, if a candidate furnish false / wrong information or suppress any facts, such application will be rejected and action will be taken against such candidates.

Last year it was experienced that candidates are taking much time to select College and courses. Such delay is preventing to complete listed students for the day. So to avoid such delay in counseling, only **5 minutes** will be allowed for a candidate to select course at the time of counseling. Count down will be started from the beginning of counseling of a student. If the candidate has failed to exercise his/her choice within 5 minutes (Count Down come to zero) the software will reject the candidate's chance and candidate will be allowed to select the course and subject, only after completing the

whole students listed for counseling for the day. So all the candidates should come with preparation for counseling.

Detailed time schedules for the process of online application for the allotment of higher studies seats to the BE/B.Tech for the year 2020-2021, is as given below.

There will be No Counseling on Sundays and National Holidays. The Number of counseling center shall be limited at Senior Secondary Schools in Amini, Agatti, Androth, Chetlat, Kadmath, Kalpeni, Kavaratti, Kiltan, Minicoy.

The principals of all islands shall be designated as the Registration Officers of the Counseling and they have to furnish authenticated data directly to the officials concerned in the NIC. The candidates should not submit application for Higher Studies to the Directorate of Education



The Principal shall provide the E-mail ID and contact details to the NIC. Therefore the Registration Officer concerned (Principal) will furnish the details in this regard by 21/09/2020 to the Department for onward transmission to NIC.

The Department has not created any agency or group to disseminate any information regarding the seat allotment and the Director of Education has reserve the

The candidates are advised to visit seat E-counseling site for latest updates/news related for the counseling schedule.
